## DOG SHOW RULES

1. Dogs must be on leash except when being judged in the ring.
2. No harsh corrections or disciplining will be allowed on show grounds.
3. Standard collars (buckle, snap, or choke) are required on show grounds. NO tags may be worn in the ring.
4. No shock collars, prong collars, head halters are allowed on show grounds.
5. Dogs must be ready for judging. Judges will not wait for any dog holding up a class.
6. Please clean up after your dogs and do not litter.
7. By signing the entry form, you agree to adhere to the rules and regulations set by MBDCA.
8. Goldengait Farm is a working farm. Please do not allow dogs in any areas other than established exercise areas and show areas.
9. It is the owner's responsibility to make sure their dogs are vaccinated or sufficiently protected from disease. Dogs that appear ill will be dismissed.

**Important Information**

The show site will open 1 hour before judging each day. The show site will close 1 hour after the conclusion of judging each day.

Parking is limited, so please follow the included parking map. We have allowed space at the front for judges and also for temporary loading and unloading. Additional parking is available by following the gravel drive around the building and towards the house. Please do not park on grassy areas as these are for pottying dogs.

Please check in at the Secretary's Table. We will have your armband number(s). Then you can check in at ringside.

The floor is fully matted. However, some dogs find the floor to be a little slippery, especially if they have a lot of hair between their pads or are jumping high and fast. If you are concerned about your dog slipping while in the ring, I recommend that you bring some Show Foot or Tacky Paw. There may be some available at the show site, but you should bring your own if you can.

It is your responsibility to be ready to show when it is your time in the ring. Latecomers will be accommodated at the Judge's discretion.

Please keep your crating area clean and all aisles clear.

Please clean up after your dogs anywhere and everywhere on the grounds. The Mixed Breed Clubs have a great reputation for leaving the grounds cleaner than when they arrived; please keep it that way!

The Icebreaker get-together is Friday night at 7pm at the Elmer's Restaurant in Hillsboro. If you are coming from the hotels, follow directions to Baseline Road in downtown Hillsboro. Instead of turning left at 1st Street (to go to the show site), continue on Baseline for one block and turn left into the Elmer's parking lot (just past Hillsboro Vet Clinic).

The Judges' Dinner is Saturday night, approximately 7pm, at the Reedville Cafe in Hillsboro. The restaurant is on the corner of Cornelius Pass Road and TV Highway (Hwy 8). Directions and a sign up list will be available at the show. The Reedville Cafe is conveniently located between the show site and the hotels. Please join us in thanking our judges and having a great time!

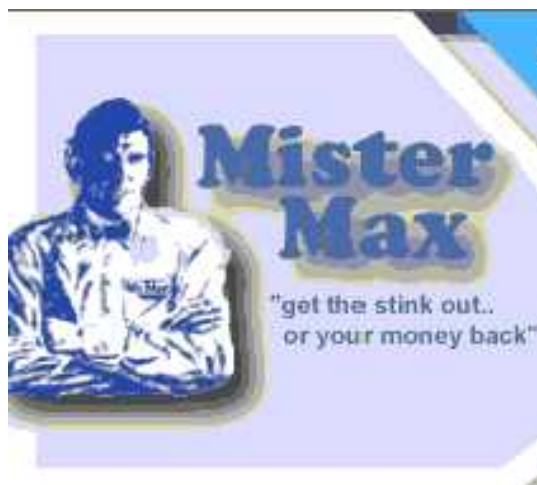

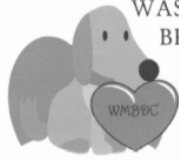
